## SELECTION OF HORTICULTURE EXTENSION WORKERS ON CONTRACTUAL BASIS

The Deputy Director of Horticulture, Balasore invites application from eligible candidates for direct recruitment of Horticulture Extension Workers (HEW) on contractual basis in the Revenue District of Balasore .

**1. EDUCATIONAL QUALIFICATION :**

A candidate must have passed +2 Science or equivalent qualification from a recognized university or institution .

**2. AGE LIMIT :**

The Candidate applying for the post of HEW must have attended the age of 21 years and must not be above 32 years of Age on 01.01.2014 the upper age limit is relaxable by 5 year in case of SC, ST, women / 3 years in case of SEBC candidates and 10 years in case of orthopedically handicapped candidates.

**3. TERMS & CONDITIONS :**

A candidate shall be

- a) A citizen of India and permanent resident of Odisha.
- b) of good moral character, good physique and free from organic defect.
- c) Must be able to speak, read and write Odia and shall have passed a test in Odia equivalent to the M.E. School standard or shall have passed matriculation or equivalent examination with odia as medium of examination in non language subject or passed M.E. School standard.
- d) Should preferable come rural area and comes from small marginal farmers family .
- e) The selected candidate will be engaged on contract for consolidated remuneration of Rs. 5,200/- P.M. and will undergo training with stipend as admissible for one year diploma in School of Horticulture Khurda .
- f) The candidate engaged on contractual basis shall not claim for regularization of their service either during the period of their engagement or after its termination .
- g) The candidates so engaged cannot claim for their transfer to other district .

**4. Method of Selection :**

Selection of the candidates shall be made on the basis of carrier marks obtained in the HSC, +2 Science or equivalent qualifications.

6. One hearing impaired(H.I) candidate will be given appointment from the community from which He/She representing .

**7. Documents to be submitted :**

True copies of the following documents duly attested by a Gazetted Officer not below the rank of class – II ( Group-B) and signed by the candidates shall be attached with application form -

- a) H.S.C. Examination or equivalent Certificate in support of age and date of birth .
- b) Certificate in support of passing +2 Science / or equivalent.
- c) Mark sheet in support of qualifying examination (H.S.C. Examination or equivalent & +2 Science or equivalent)
- d) Caste Certificate from competent Revenue Authority in case of SC/ST/SEBC candidates .
- e) Certificate claiming to have come from rural area and small or marginal farmer family to be obtain from Asst. Agriculture Officer /Asst. Horticulture Officer of the Block .
- f) Character Certificate from two Group – B Officers (not below class-II)
- g) Certificate of Good conduct from the institution in which He/She last studied .
- h) If employed “ No objection Certificate “ from the employer is to be submitted .
- i) Two copies of attested recent passport size photographs .

**8. Submission of Application :**

Application in the prescribed forms along with the required documents shall be submitted to the Deputy Director of Horticulture, Balasore in the envelops sub-cribbed as “APPLICATION FOR THE POST OF HORTICULTURE EXTENSION WORKERS - 2014” By hand delivery in sealed drop box kept in the office of the Deputy Director of Horticulture, Balasore & in the establishment section of Colectorate, Balasore / by Registered post / Speed post on or before 24.02.2014, 5 PM. A candidate can apply in anyone district of the state, but not more, Application forms incomplete in any respect or received after the stipulated date or applying directly to the office of the Director of Horticulture, Odisha, Bhubaneswar are eligible to be rejected summarily . The authority will be in no way responsible for any postal delay or loss in transit.
